#### WCCA Financial Snapshot June 2021

Items of note on the financial statements this month include:

#### **Balance Sheet:**

- Unrestricted cash balance increased to \$1.7 Million
- Federal and state grant receivables decreased by \$59K related to collection of outstanding COVID funds
- The Endowment balance increased by \$11,255 this year bringing the balance to \$46,074

#### Income statement:

- Agency net income is \$52K this includes non-cash expense of \$242K (depreciation) and capitalizable expenses of \$182K (fixed asset clearing account). Note these non-cash expenses can be added back to the bottom line to indicate cash basis performance. We have a cash surplus of approximately \$475K.
- Agency Net Income is below expected budget this year due to unreimbursed expenses in the Federal CACFP food program, cancellation of state and county supported wrap around childcare services throughout FY 2020-2021 and reduced revenue service units in HCCBG transportation.
- Indirect costs for the month were: \$155,826.33 which includes accrued payroll for July
- Early Childhood Education Services is showing an operating loss of \$58K for the year. The loss is related to unreimbursed expense in the CACFP food program and the cancellation of voucher funded wrap around services for the year.

### COVID-19

Total COVID related expenditures for the year are \$877,579. The final total includes COVID funds that replaced ROAP Transportation Programs and Housing Admin operating and Indirect COVID expenses for the year.

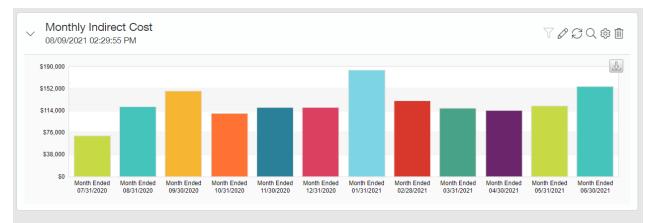
## Monthly Unrestricted Cash Balance
