
Average Daily Attendance by Program Type




Curriculum Implementation - CLASS

- Four HS classrooms assessed.
- 3 out of 4 had a different teaching team than last year.
- 1 classroom's scores were lower due to multiple high needs/challenging behaviors that are being addressed but do affect the climate of the classroom and behavior management. This also makes promoting concept development a bit more challenging.
- Scores are close to the quality threshold for Emotional support, a bit lower for Classroom organization, and higher for Instructional support. However, while all individual scores were above competitive thresholds, some are a bit close so we do need to provide training and coaching to raise scores particularly in Instructional Support. New teachers also have not had training.



Child Development Assessments


Snapshot of Widely Held Expectations Early Head Start/Head Start Fall 2022

Education Levels of Teaching Staff



Lead Teacher Education Levels




Coaching Updates

- 278 coaching contacts
 - 21 staff received intensive coaching
 - 25 staff received standard coaching
- 3 days of intensive onboarding for 2 new EHS teachers and onboarding for 5 CCP-EHS teachers
- CLASS assessments were completed for 2 HS classrooms, 2 dual HS/NC Pre-K classrooms and 2 NC Pre-K classrooms. 1 NC Pre-K classroom will be scheduled for November.

Development & Behavior Screenings



All currently enrolled children either have the screening completed or are in process of being scheduled. We are having difficulty scheduling due to cancellations and illness.



We have completed 227 ASQ-3 and ASQ: SE -2 and are continuing to complete scheduled ASQs with families.

We are scheduling new enrollees as soon as possible. Three new classrooms opened in October.

We are enjoying getting to know the families and having this information immediately and knowing where our children are before school starts so we can start the referral process right away if needed.





Partnership (CCP), EHS, and FCCH Updates

Two CCP sites, Little Blessings Learning Center and Kids' Kingdom Preschool, were included in the recent FA2 review. Directors and teachers at both sites made a laudable effort to demonstrate their professionalism and adherence to Early Head Start performance standards.

Forty EHS children were served through CCP in the month of September.

A new family child care home in Henderson County will soon receive its child care license and, barring any unforeseen circumstances, looks forward to potentially partnering with WNC Source adding EHS spots to their program.

The search for FCCHs in Transylvania, Polk, and Rutherford counties continues.

Head Start / NC Pre-K Program Updates

- We continued to **gradually open Head Start & NC Pre-K** classrooms throughout October thanks to the hiring and onboarding of new teaching staff. King Creek has one additional HS and one additional NC Pre-K classroom that both opened on 10/24.
- Our annual NC Pre-K Monitoring has begun. This tool is a checklist used to monitor site information annually and provides a comprehensive summary of all information for NC Pre-K classrooms located at this site as part of regular, systematic and focused supervision of each program. The results from the Monitoring Tool (and corresponding DCDEE compliance visits) are used to ensure uniformity across programs and to develop local county/regional plans. The tool monitors each programs compliance to health, safety, curriculum, program structure, staff education and support for families. The initial tools were due by mid-November and the observations for compliance will occur between December-January.
- Annual licensing compliance visits are occurring at all facilities, these NC DCDEE regulatory site visits are conducted by state licensing consultants & monitor for compliance with all applicable child care requirements and regulations.
