Program Instructions

ACH-IM-HS-23-01 "The Role of HS Programs in Addressing Lead in Water" 3/8/2023

Lead is a toxic metal and there is no safe blood lead level for children. Because their bodies are still developing, children under the age of 6 are at greatest risk for significant and potentially lifelong health problems as a result of exposure. They are more likely to come into contact with lead through paint or dust since young children often put their hands or objects in their mouths. However, lead in drinking water can also be a significant contributor to overall exposure to lead. This is particularly true for infants whose diet consists of food and liquids made with water, such as baby food or formula. The adverse health effects of lead exposure can be both physical and behavioral. Even low levels of lead in children can lead to anemia, behavior and learning problems, and other concerns.

Head Start programs have a critical role to play in **preventing lead poisoning in children**. Programs are required to maintain a facility that is free from pollutants, hazards, and toxins that are accessible to children and could endanger their safety — and that includes lead in water and paint. As part of Head Start monitoring, programs can expect to be asked about their processes to identify lead hazards and mitigate them. This Information Memorandum highlights available resources for programs to address lead in water specifically.









We are actively hiring for Head Start and NC Pre-K teaching positions for both existing vacant classrooms and new facilities. We hope to have multiple new classrooms open before the end of the program year. We are very excited to be able to provide children these services as they prepare to transition to Kindergarten!

LETRS: Currently we have three HS/NC Pre-K teachers registered and attending the state required early literacy training. New Site Administrators will also be trained early next program year! *LETRS®* for Early Childhood Educators provides vital, practical information for building language and cognitive skills through a balance of teacher and student-centered social, emotional, and physical development essential for young children before learning to read and write.



Partnership (CCP), EHS, and FCCH Updates

Laurie Morin (our CCP FCHC provider) has begun mentoring an EHS teacher at Little Red school. Laurie created a teacher's basket of goodies for her first mentoring visit filled with thoughtfully chosen items to support a new EHS teacher.

We are working on ways to support our CCP Directors with retention and teacher recruitment so they can enroll more EHS children in their program and we can reach full enrollment in 2024.
