

Head Start / NC Pre-K Program Updates



Head Start & NCPK teachers are on their (much deserved) summer break. Henderson county HS/NCPK teachers will return on August 7th and Transylvania HS/NCPK teachers will return on August 21st for the 2023-24 school year. Teachers will have pre-service training and multiple "teacher work-days" in their classrooms in preparation of new children. Everyone is anticipating a wonderful new program year!



Interviewing actively continues for all open HS/NCPK teaching positions. All new staff will begin on-boarded/orientation on July 19th. Onboarding includes extensive training on state / OHS required topics, professional development, getting acclimated to our WNCSource agency & classroom observations.

Little Red School - Six of 12 EHS Spots Filled. Needs to hire two teachers.

- Room LR1: Temporarily closed due to lack of staff. Four EHS spots available when reopened. Est. re-open August 2023. Needs to hire two teachers.
- Room LR2: Six of eight EHS spots filled.
 One permanent teacher, one long-term substitute. Needs to hire one permanent teacher.

Little Blessings: Sixteen of 20 EHS Spots Filled. Six teachers on staff, needs to hire two teachers.

- Room: Waddlers: Eight of eight EHS spots filled
- Room Toddlers 1: Eight of eight spots filled

Laurie's Child Care - Five of Five EHS Spots Filled. Fully staffed.

Five of five (FCCH) EHS spots filled. One teacher

Kids' Kingdom - Thirteen of 21 EHS Spots Filled. Fully staffed.

- Infants/Ones Room: Five of eight EHS spots filled, and three filled with subsidy. Staff: Two teachers.
- Toddler 1 Room: Four of eight EHS spots filled. Three are subsidy/private pay. One open EHS spot. Staff: Two teachers
- Toddler 2 Room: Four of eight EHS spots filled. Four spots are subsidy/private pay. Staff: Two teachers

We have three new partners in our CCP program!!! Two are in Henderson County; one is a center, Little Bright Minds, and the other is a family child care home, God's Gifts Child Care. Our third new partner is also a family child care home, Above and Beyond Child Care, in Rutherford County. This translates to a minimum of 18 new EHS spots.

Professional Development Updates
