



Family Engagement in Children's Education

Home Visits between staff and families facilitate the building of trusting relationships and community with families. We complete these with families before or within 2 weeks of a child enrolling into a classroom.

219 children have had a HV with their teacher

- 55 children will have a HV within the next 2 wks
- 34 children dropped before having a HV
- 77 children have not yet had a HV





- 7 classrooms are using **My Family App** to share curriculum resources with families.
- 21 families have viewed resources shared.

Coaching Updates

Coaches are beginning to utilize **Coaching To Fidelity App** to support the Practice Based Coaching Cycle.

Currently observing Early Head Start classrooms to determine level of fidelity for implementation of the curriculum. During October Head Start & NC Pre K Classrooms will be observed.

Development & Behavior Screenings

- 222 Children have received Development & Behavioral screenings this program year.
- 65 Children have a "Referral Recommended" status. Some families have requested referrals and we are supporting those.
 Others we will re-evaluate when 1st Checkpoints come in.

42 for Developmental Needs only 12 for Behavioral Needs only 11 for both

40 Children are scheduled to have ASQs completed within 45 day requirement.

Early Head Start Updates/Highlights



We have one family currently going through the pre-licencing process to open a family child care home in Henderson County.

Work continues to encourage the opening of new family child care homes in Transylvania County.



Professional Development Updates

We have hired a Professional Development Coordinator, Hunter Weatherford!

Using the NHSA Academy, Jennifer Wolfe achieved her Infant Toddler CDA!

45 staff (35%) are working on continuing their education.





September 5th was Day 2 of Pre-Service Training: We spent another day at Lutheridge Camp & Conference Center. We opened with a Community Meeting and Welcome message from David White. Other activities led by staff including a re-look at our mission & vision, Mindful moment singing Bob Marley together, Playing Who Wants to Be a Millionaire with ERSEA facts, and making bracelets to remind us of safety first in the classroom. We also spent time learning more about coaching, the early intervention team, and family advocates.

Apprenticeship Program: 5 Apprentices are finishing up their 1st rotation of classrooms. Most will be moving to their next classroom October 16.
