



Family Engagement in Children's Education

Home Visits between staff and families facilitate the building of trusting relationships and community with families. We complete these with families before or within 2 weeks of a child enrolling into a classroom.

248 children have had a HV with their teacher45 children have not yet had a HV

Coaching Updates

Coaches are beginning to utilize Coaching To Fidelity App to support the Practice Based Coaching Cycle.

Early Head Start classrooms Fidelity Tools have been completed to determine level of fidelity for implementation of the curriculum. During October the Coaches have worked with Head Start & NC Pre K Classrooms to complete determine their Fidelity. The full out come for all programs will be reported in December.

Head Start / NC Pre-K Program Highlights

Playful Learning and Joyful Teaching in Preschool / Early Literacy Development: Letterland



WNCSource has begun introducing the Letterland program within our HS/NCPK classrooms. This is in alignment with our "School Readiness" goals and supports the Kindergarten Transition process. Letterland teaches early phonics using a story-based approach to introduce shapes and sounds for preschool age children. The story logic engages students leading to long term retention of concepts. It is wonderfully multi-sensory and activates every learning channel through music, actions, alliteration, movement, song, art, games and role-play.

On October 10th, our HS/NCPK children attended a performance of "LetterLand Live" presented by the Flat Rock Playhouse performers at our host Clear Creek Elementary school. The children enjoyed live singing, dancing and a visual introduction to the letterland characters.

Plans are being developed to provide Early Childhood focused Letterland training for our teachers in the spring of 2024.

There was also time for staff to engage with and get familiar with the teaching strategies online platform specifically creating lesson plans and accessing items such as mighty minutes, Book conversation cards etc. The training was such a success that we have already begun the process to get Kathy back out here for another training for CCP staff on February 2nd.
