## **Highlights**

### **Facilities**

The construction of the Columbus Children's Center is progressing as planned and is expected to be completed in the middle of summer. We are currently in the process of exploring various options for classroom and office furniture. Anna Williams, our staff recruiter, has been proactive in filling the job positions for the center. She has attended job fairs, visited Polk County High School, and met with representatives from Isothermal Community College to kickstart the hiring process for qualified staff members.

The State of North Carolina and RTI International, a nonprofit research institute, have launched the Clean Classrooms for Carolina Kids program to tackle the issue of lead and asbestos hazards in public schools and licensed childcare facilities. This program will help these institutions identify and eliminate exposure to such hazards in their building infrastructure. Previously, the Clean Water for Carolina Kids program had tested all childcare centers in the state for lead in water at drinking and food preparation taps. The new Clean Classrooms for Carolina Kids program expands the previous initiative. WNCsource Child Services and our Safety and facilities team will partner with the NC Clean Classroom program, and all site supervisors will enroll in the program and receive a PIN for enrollment. All our Site Supervisors are on target to meet the May 1, 2024, deadline to register their children's center into the State portal.

**SUBJECT:** Fiscal Year 2024 (FY 2024) Head Start Funding Increase

#### **INSTRUCTION:**

President Biden signed the Further Consolidated Appropriations Act, 2024 (P.L. 118-47), into law on March 23, 2024. The funding level for programs under the Head Start Act (the Act) is \$12,271,820,000, an increase of \$275 million over FY 2023. This funding level provides all Head Start, Early Head Start, and Early Head Start-Child Care (EHS-CC) Partnership grant recipients a 2.35% cost-of-living adjustment (COLA).





Each OHS grant requires us to serve 10% of our cumulative enrollment with children who qualify for an IEP or IFSP. We include NC Pre-K for comparative. Disability Waiver was submitted for the Expansion Grant.

Diagnosed Disabilities include:

- Autism (22)
- Health Impairment (10)
- Developmental Delay (31)
- Speech or Language Impairment (13)
- Hearing Impairment (1)

Team is supporting 5 children with an initial Early Alert to determine any developmental needs.

## **Mental Health**

8% of enrolled children (37) received support from the Early Intervention Team during March for behavioral/mental health needs.

83 Behavior Incidents logged during March for 26 children in 12 different classrooms.

Team is supporting 5 children with an initial Early Alert to determine any behavioral needs.

Small groups with the Al's Pal's social-emotional curriculum are going well and have received positive feedback from teachers. The students seem to be enjoying the lessons and we will continue to monitor progress.

## **Early Intervention Updates**

Our Classroom Specialist Nathalie Steffan Santos is starting support intensively in a classroom at Etowah which has a lot of diverse needs.

We sent out the first edition of our Early Intervention newsletter in March and are currently writing April's.

A survey is being sent out to parents whose children have IEPs and are moving into Kindergarten next year to talk about parental rights and the transition. We will follow up with any parent who requests it

We are working on a partnership with the Children and Family Resource Center to try to roll out Circle of Security trainings to staff and parents.

One of our Behavior Interventionists is leaving us so we will be looking at different ways to fill that vacancy in the most efficient way possible to support our current needs.



#### **Community Events: Giving Back to Non-Profits**


- Grace Lutheran Church "Servant Saturday" social ministries

## Head Start/NCPK Classroom Highlights

#### **Gardening at our Dana Children's Center**

Introducing gardening to preschool children at school offers a multitude of benefits:

- Educational Value: Gardening provides hands-on learning experiences on observing the plant life cycle
- 2. **Promotes Healthy Eating Habits:** Gardening encourages a positive attitude towards fresh produce and can help establish healthy eating habits from a young age.
- **3. Encourages Responsibility:** This fosters a sense of ownership and accomplishment as they watch their efforts yield results.
- **4. Enhances Fine Motor Skills:** Activities like planting seeds, watering plants, and picking produce help develop fine motor skills and hand-eye coordination.
- **5. Promotes Outdoor Activity:** Gardening encourages children to spend time outdoors, fostering a connection with nature and promoting physical activity.

## Partnership (CCP) Updates

Slide 2

At this time we have six partners in the CCP program. Four in Henderson County, one (combination of two sites) in Transylvania county, and one in Rutherford County.

Our next CCP Creative Curriculum training for teachers is coming up in June 2024 conducted by a professional Teaching Strategies trainer. We look forward to the teachers enjoying their next session where they will learn more about implementing Creative Curriculum.

The curriculum trainings for CCP teachers will now be scheduled quarterly with supplemental monthly videos for the CCP teachers to watch to continue to build their curriculum implementation skills.
